Class A & B beer licenses are \$100.00, Class A & B liquor licenses \$300.00, Class A & B Combination licenses \$400.00, Picnic licenses \$100.00, Liquor application publication fee \$10.00, Operator's license application fee \$15.00, Cigarette and Tobacco license application fee \$10.00, Land Use Application fee \$50.00, Cat License \$10.00, Weed rate \$200.00.
- Tractor and Snow plow rates: Trustee: Robin Gutowski made a motion to approve the rate for tractor and snow plow rates at \$100/ hour in 15-minute increments. Trustee: Nicole Simpson seconded the motion.
