## **Meeting Minutes for the August 11, 2025 Village of Radisson Regular Board Meeting**

CALLED TO ORDER: President, Seth White, opened the Village of Radisson regular board meeting at 5:00pm on August 11th, 2025.

Board Attendees: President, Seth White, Trustee, Joanne Ferguson, Trustee, Nicole Simpson.

Other Attendees: Public works employees Robert Sampson and Leonard Thorson, Clerk, Tera Rautio, and 3 citizens.

### PLEDGE OF ALLEGIANCE RECITED

APPROVAL OF AGENDA: Motion to approve, the August 11th, 2025 regular meeting agenda, made by N.Simpson, seconded by J.Ferguson, motion carried.

APPROVAL OF MEETING MINUTES: Motion to approve, the July 14th, 2025 regular meeting minutes, made by N.Simpson, seconded by J.Ferguson, motion carried.

### APPROVAL OF TREASURER REPORTS:

Village Treasurer Report (VTR): N.Simpson motioned to approve VTR, seconded by J.Ferguson, motion carried.

Water/Sewer Treasurer Report (W/STR): N.Simpson motioned to approve W/STR, seconded by J.Ferguson, motion carried.

Village Voucher Report (VVR): J.Ferguson motioned to table the VVR since the report was misplaced, seconded by N.Simpson, motion carried.

Water/Sewer Voucher Report (W/SVR): J.Ferguson motioned to table the W/SVR since the report was misplaced, seconded by N.Simpson, motion carried.

Public Works/Water & Sewer Update: R.Sampson stated that last two (2) water tests were safe per the DNR, two (2) more tests are needed at this point. R.Sampson to do annual water tower hatch inspection soon. R.Sampson stated there should be a permit or report that states the water piping material used, R.Sampson tried calling Duran Construction with no luck. S.White advised public works employees to continue research as a priority project and utilize Diamond Maps. R.Sampson provided list of properties needing to be mowed, Clerk to prepare notice letter with deadline date before Village will mow and charge property owners.

AUDIENCE RECOGNITION: Citizen asked for the Village to stop using roundup due to kids playing in and near ballpark sprayed areas. S.White advised that we do not use roundup, we use herbicide purchased from the feed mill and is safe after 3 hours from application. S.White advised we will research the herbicide further and possibly change to a different weed treating chemical that is safer to humans and animals.

OLD BUSINESS: a) Village of Radisson ballpark concession stand was stained. Painting still needs to be completed for bleachers, dugouts, and scoreboard sign. b) J.Ferguson motioned to un-table the Resolution to combine the Clerk and Treasurer duties, seconded by N.Simpson, motion carried. S.White motioned to remove the Resolution to combine the Clerk and Treasurer duties, seconded by N.Simpson, motion carried.

NEW BUSINESS: a) N.Simpson motioned to approve the removal of Carlene Vaverka as Village of Radisson clerk and removal of Carlene Vaverka from the Village banking institutions, seconded by J.Ferguson, motion carried. b) N.Simpson motioned to approve the addition of Tera Rautio as official Village of Radisson clerk and addition of Tera Rautio to the Village banking institutions, seconded by J.Ferguson, motion carried. c) N.Simpson motioned to approve the Charter Ordinance No. 25.8.11 to re-combine the Clerk and Treasurer positions, seconded by J.Ferguson. S.White motioned for voting on the Charter Ordinance No. 25.8.11, S.White voted yes, N.Simpson voted yes, J.Ferguson voted yes, motion carried to adopt Charter Ordinance 25.8.11. d) S.White motioned for voting on the three (3) new Pop's Mart Fuel, LLC Operator's License applications, S.White voted yes, N.Simpson voted yes, J.Ferguson voted yes, motion carried to approve.

BOARD COMMENTS: S.White announced that although there are a lot of Village changes happening, we believe all changes are for the better of the community.

ANNOUNCEMENTS: N.Simpson announced she will be working on the next Village newsletter and that all entries are due into the Village by September 15<sup>th</sup>, 2025. S.White announced the next regular board meeting will be on September 8th, 2025, at 5:00pm.
