Meeting Minutes

CALL TO ORDER: Village President Seth White opened the village regular board meeting at 5:00pm on July 14, 2025.

Board Attendees: President Seth White, Trustee Joanne Ferguson, Trustee Nicole Simpson.

Other Attendees: Public works employees Robert Sampson and Leonard Thorson, treasurer, Steve Jagelio, clerk, Tera Rautio, and 5 citizens.

PLEDGE OF ALLEGIANCE RECITED

APPROVAL OF AGENDA: Motion to approve, the July 14th, 2025 regular meeting agenda, made by N.Simpson, seconded by J.Ferguson, motion carried.

APPROVAL OF MEETING MINUTES: Motion to approve, the June 23, 2025 regular meeting minutes, made by N.Simpson, seconded by J.Ferguson, motion carried.

APPROVAL OF TREASURER REPORTS:

Village Treasurer Report: N.Simpson motioned to approve VTR, seconded by J.Ferguson, motion carried.

Water/Sewer Treasurer Report: N.Simpson motioned to approve W/STR, seconded by J.Ferguson, motion carried.

Village Voucher Report: S.White questioned the Diggers Hotline charge, charge confirmed by R.Sampson. S.White motioned to approve VVR, seconded by J.Ferguson, motion carried.

Water/Sewer Voucher Report: S.Jagelio advised that water did get caught up on their payroll back to the Village. S.Jagelio stated the bulk of office supply charges are postage stamps, S.White asked S.Jagelio if there is a cheaper way than using stamps, S.Jagelio advised that he's looked into this and a postage meter would not save the Village postage expense. N.Simpson motioned to approve W/SVR, seconded by J.Ferguson, motion carried.

Public Works/Water & Sewer Update-Robert Sampson/Leonard Thorson: R.Sampson discussed having the contractor from last year come to check sewer pipes again, different section than last year, Board agreed with the benefit, S.White advised R.Sampson to set clear boundaries with the contractor. R.Sampson stated he talked with the Town President regarding gravel, R.Sampson to gather more information on cost of gravel from Town. R.Sampson discussed water chlorination and further testing, audience member asked what we are testing for, R.Sampson and S.White responded. S.White discussed the ballpark fixing and painting, to make it safe and looking good. S.White asked R.Sampson and L.Thorson what they have found out about the water pipes, R.Sampson stated further research needs to be done to confirm piping material used. R.Sampson advised water tower inspection to be done within the next 45 days.

AUDIENCE RECOGNITION: Audience citizen asked about reimbursing B.Heath for mowing ballpark, S.White advised he has spoke with B.Heath in regards to this matter. Same citizen addressed the curb & gutter main street cleanup prior to Harvest Fest event, S.White agreed the Village will get the cleanup done. S.White also stated they are in discussions with the post-office bldg. owner to fix the private road in front.

OLD BUSINESS - none

NEW BUSINESS: Discuss/Act on Amendment to combine Clerk and Treasurer duties. S.White read the resolution, attached, to combine the Clerk and Treasurer duties into one, audience citizen commented the resolution is in error, that it needs to be done by Charter Ordinance vs. resolution, another citizen said there should also be a referendum for the Village residents to vote on it, N.Simpson motioned to table this resolution until next meeting, S.White seconded the motion, motion carried.
