- 1) President Seth White called the meeting to order at 5 pm.
- 2) Pledge of Allegiance was recited
- 3) Agenda approved by Seth White and seconded by Nicole Simpson, all in favor, motion carried.
- 4) Nicole Simpson motioned to approve April 14, 2025 Minutes and seconded by Seth White. All in favor, motion carried.
- 5) APPROVAL of Treasurer Reports
 - a. Motion to approve the Village Treasurer Report made by Seth White and seconded by Joann Ferguson, all in favor, motion carried.
 - b. Motion to approve the Water/Sewer Treasurer Report made by Seth White and seconded by Nicole Simpson, all in favor, motion carried.
 - c. Motion to approve the Village Voucher Report made by Seth White and seconded by Nicole Simpson, all in favor, motion carried.

 - d. Seth White motioned to approve Resolution # 20250509-C: Establishing a Temporary Committee Titled "Beautification of Radisson" and seconded by Nicole Simpson, all in favor, motion carried.
 - e. Seth White motioned to approve Resolution#20250509: to Initiate a Six-Month Pilot Program for Live Streaming Monthly Village Board Meetings and seconded by Nicole Simpson, all in favor, motion carried.

 - a. Seth White motioned to approve the replacement of the Michael Villard Memorial previously displaced by the Water Tower Construction. Seconded by Nicole Simpson, all in favor, motion carried.
