## **Meeting Minutes for the November 10, 2025 Village of Radisson Regular Board Meeting**

**CALLED TO ORDER:** President, Seth White, called the Village of Radisson special board meeting to order at 5:00PM on Monday, November 10, 2025.

**PLEDGE OF ALLIEGIANCE RECITED**

**APPROVAL OF AGENDA:** N.Simpson motioned to approve the November 10, 2025 regular meeting agenda, seconded by J.Ferguson, motion carried.

**APPROVAL OF MEETING MINUTES:** N.Simpson motioned to approve the November 8, 2025 special meeting minutes, seconded by J.Ferguson, motion carried.

**APPROVAL OF TREASURER REPORTS:**

Village Treasurer Report (VTR): J.Ferguson motioned to approve VTR, seconded by N.Simpson, motion carried.

Water/Sewer Treasurer Report (W/STR): N.Simpson motioned to approve W/STR, seconded by J.Ferguson, motion carried.

Village Voucher Report (VVR): S.White motioned to approve VVR, seconded by J.Ferguson, motion carried.

Water/Sewer Voucher Report (W/SVR): S.White motioned to approve W/SVR, seconded by J.Ferguson, motion carried.

Public Works/Water & Sewer Update: L.Thorson stated we had bad water samples again and therefore have started chlorinating again. S.White stated he put out a notice on our Facebook page regarding the water chlorination. L.Thorson advised we had Energetics fix some sort of fault in the electrical on well #2 and well #4, and they are working properly now.

**OLD BUSINESS:** Board discussed the votes received and not received back from the utility billings on the following: a. whether to stop live streaming of regular monthly meetings; and b. whether to have a community garden at 3752N Clark Street. Board decided to investigate other voting options on these open items.

**NEW BUSINESS:** Village Board reviewed the recently received Radisson Fire Department 2026 Fire Contract that is due January 1, 2026. Each Board member signed the two (2) original contracts; and S.White motioned to approve the 2026 Radisson Fire Department Contract, seconded by J.Ferguson, motion carried.

**BOARD COMMENTS:** S.White announced our schedule in regards to the proposed 2026 budget; stating our next budget meeting will be Thursday, Nov. 13, 2025 at 6PM; with the budget to be published on Wednesday, Nov. 19; and our public levy/budget hearing to be on Thursday, Dec. 4 with the time to be determined; and then at our regular meeting Dec. 8 we would adopt the budget. N.Simpson verbally and in writing resigned effective immediately after the Village meeting and handed her resignation letter in an envelope to the Village Board.
