 - a. Report detailing sewer lift station #3 pump issues, quote to fix, and overall plan – Crane Engineering

 - a. Village Hall roofing quote discussed and approved during the June 30, 2026 special meeting – this quote is null and void as it has been determined this project must follow the proper publishing and sealed bids process.
 - b. ATV/UTV ordinance amendment – Sign relocation and installs, board vote needed on whether the Village relocates and installs ATV route signs or the County does and we get billed.
 - c. Address C.Marcucci's statement, "the Board cannot add to an agenda at the beginning of a board meeting." Under Wisconsin's Open Meetings Law, a village board generally cannot add new substantive items to their meeting agenda at the beginning of the meeting. A village board can reorder agenda items at the beginning of the meeting. However, they cannot add new, un-noticed items or make language changes that expand the substantive scope of what was originally published for the public. Under Wisconsin's Open Meetings Law, a village board can generally add new items for discussion only to an agenda at the start of a meeting, provided the items are brief, non-actionable, and directly relate to the board's purview. Additionally, non-agenda items brought up by audience members are restricted from immediate board action.
 - d. Address C.Marcucci's statement, "...believes grass/weed cutting charges have to be adjudicated and cannot be charged to the property owners property taxes if the charge goes unpaid." Yes, villages in Wisconsin can legally charge property owners for cutting their grass. Under state authority, municipalities declare tall grass and weeds a public nuisance. If an owner ignores an official warning, the village can mow it and bill the owner, eventually placing unpaid fees on the property's tax roll. Village ordinance Ch.7.07 Weed/Grass Control Notice was posted 5/27/26.
 - e. Address C.Marcucci's written allegations that the village is collecting PFP (Public Fire Protection) charges twice, and her request for a refund of all PFP charges in 2025 and 2026. PFP charges are collected as follows: \$18,955 collected as a municipal charge and \$26,984 collected as a direct charge to the retail general service customers. Under Wis. Stat. § 65.90(5)(a), a municipality's governing body may authorize changes or alterations to a previously adopted budget at any time during the fiscal year. The 2025 adopted village budget will be amended as needed, (with no alteration to the general levy) once the village accounting system changes are complete (est. completion Sept. 1st, 2026).
 - f. Grass/Weed ordinance Ch. 7.07 violations – letters mailed out to property owners July 21, 2026.
 - g. Blocking southwest alleyway between Home Street and Church Street – prohibited activity notice letter mailed out July 21, 2026.

- a. Discuss acquiring loan to cover village hall needs, e.g. roof, soffit, fascia, exterior paint, doors, windows, parking space, and to cover other village needs, e.g. new lawn mower, garage doors, old well behind village hall repair, and pavilion maintenance.
- b. Discuss and act on ACH Origination Agreement between Village of Radisson & Chippewa Valley Bank.
- c. Discuss and act on: Recycling Responsible Units (RU's) required to update their recycling ordinance
- d. Discuss vacant lots, standby water charges, and back-billing of all vacant buildable lots with accessible water of which have not been billed since January 2025.
- e. Discuss sewer usage rate (\$8.46 per 1000 gallons and \$2.00 over 1000 gallons) and sewer monthly service charges based on meter size (5/8" and 3/4" pipes = \$46.03; 1" pipe = \$52.34; and 1 1/2" pipe = \$62.86). Currently our water usage rate of \$9.94 per 1000 gallons is higher than our sewer usage rate which is very uncommon because treating sewage is more costly than clean water.
